MEMORANDUM OF UNDERSTANDING

BETWEEN

THE DIPLOMATIC ACADEMY OF THE MINISTRY OF FOREIGN AFFAIRS OF THE
REPUBLIC OF KOSOVO

AND

THE HUNGARIAN INSTITUTE OF INTERNATIONAL AFFAIRS

The Diplomatic Academy of the Republic of Kosovo and the Hungarian Institute of International Affairs (hereinafter referred to as "Parties");

RECOGNISING the spirit of cooperation that exists between Hungary and Kosovo and WILLING to promote closer collaboration on training of diplomats;

Have agreed to the following:

Article 1

Purpose

The objective of this Memorandum of Understanding (MOU) is to create conditions for maintaining regular contacts and promoting cooperation between the Parties.

Article 2

Cooperation

The Parties will cooperate on exchange of information and experiences concerning their respective programs of study and research, seminars and other academic and training activities.

The Parties may explore the possibilities of other forms of cooperation under the scope of objectives of this memorandum.

Article 3

Issues of mutual concern

The Parties will promote contact and exchange of trainees, experts and researchers.

The Parties will encourage the study and research, as well as exchange of information on national and international publications, especially in areas of mutual interest.

Article 4

Exchange of information

The Parties will exchange information and views related to international trends and advances in training and research in diplomacy, foreign policy, international relations, international law, foreign economic relations, political science and other relevant areas.

Article 5

Projects undertaken jointly

The Parties will decide, through the pertinent diplomatic channels, the specifics and logistics of every project they jointly undertake. For this purpose, protocols laying down the terms and conditions of the proposed exchanges will be concluded if necessary.

Article 6

Financial conditions

Forms, durations and financial conditions of exchange and training of representatives of the Signatories will be agreed between the Signatories.

Article 7

Settlement of Disputes

Disagreements and disputes regarding the interpretation or application of this Memorandum will be settled between the Parties through consultations.

Provisions of this protocol may be amended by mutual written consent of the Parties.

Article 8

Entry into force

This Memorandum will come into effect on the date of its signature and will continue to have effect for a period of three years. Thereafter, it may automatically be renewed for equal periods, unless terminated by any of the Parties by giving a written notice of ninety (90) days to the other Party prior to the date of termination of the Memorandum. The termination of this Memorandum will not affect ongoing projects.
