MEMORANDUM OF UNDERSTANDING
between
DIPLOMATIC ACADEMY OF THE REPUBLIC OF KOSOVO
and
UNIVERSITY OF PRIZREN ‘UKSHIN HOTI’¹

University of Prizren ‘Ukshin Hoti’ and Diplomatic Academy of the Republic of Kosovo have agreed to sign the Memorandum of Understanding with the aim to cooperate and exchange the experiences in the field of diplomacy and international affairs, of international law and other academic disciplines.

Article 1.

Purpose

University of Prizren and the Diplomatic Academy will cooperate in the field of exchanging lecturers, providing lectures in the field of diplomacy, international law, modern political history as well as studying and researching the topics of mutual interest. Both institutions will mutually cooperate and will provide to each other the proper assistance during the organization of events that are of mutual interest.

Article 2.

Cooperation

Both parties of agreement have agreed to provide lectures, conferences and seminars for candidates on topics of mutual interest in the premises of University of Prizren "Ukshin Hoti" and Diplomatic Academy of the Republic of Kosovo.

Article 3.

Provision of lecturers

University of Prizren "Ukshin Hoti" will provide lecturers from the Faculty of Philosophy, Faculty of Law, Faculty of Philology and Faculty of Economics. Diplomatic Academy of the Republic of Kosovo will provide lecturers from the diplomatic bodies accredited in the Republic of Kosovo, among the diplomats of the Republic of Kosovo, as well as from international homologue institutions.

Article 4.

Publication of works

Both institutions will facilitate the publication of works from two partners to the respective institutional bodies, as well as the texts of interest from other public or private institutions, whether domestic or international.

Article 5.

Exchange of information

University of Prizren "Ukshin Hoti" and the Diplomatic Academy of the Republic of Kosovo shall exchange information of mutual interest, including individual or joint participation in international meetings or conferences.

Article 6.

Status

This document constitutes the entire agreement between the parties. The agreement is not considered to be a binding financial contract, it is designed for the purpose of promotion, cooperation and institutional development of both parties.

Article 7.
Entry into force, duration and termination

The Memorandum of Understanding shall enter into force on the day of signing and remain in force for five years. The agreement can be terminated by one of the signatories after submission of a written notice at least 120 days prior termination. Activities commenced prior written notice for termination of agreement, will be completed according to the plan within the time limit of 120 days, unless in cases where the parties agree to take another decision.

The agreement shall remain in force automatically for five additional years, if the parties do not commence the procedure for terminating this agreement.
