

## PROTOCOL OF AGREEMENT

on

Subsidized hours by the Embassy of France in Kosovo for the first semester of 2015 for diplomats enrolled at the Diplomatic Academy.<sup>1</sup>

Between:

The Embassy of France in Kosovo, Ismail Qemali Street No. 67, 10000 Prishtina, Kosovo, represented by Ms. Maryse DAVIET, hereinafter Embassy

And

The Diplomatic Academy, Luan Haradinaj Street, Prishtina, Kosovo, represented by its Director Mr. Ambassador Skender DURMISHI, hereinafter Diplomatic Academy

Agreed as follows:

**Article 1:** The Embassy of France is organizing a session of courses for the first semester of 2015.

**Article 2:** This session includes French courses of levels A1 and A1.2 of the Common European Framework of Reference for Languages, for two groups of 7 and 8 participants each.

**Article 3:** The groups of participants are formed on the proposal of the Diplomatic Academy.

**Article 4:** The session is fully financed by the Embassy. It means a weekly course of 1 hour and 30 minutes for A1 level group (group 1), and 2 weekly courses of 1 hour and 30 minutes for the group A1.2 (group 2). The courses will last 15 weeks, from February 9 until June 1, or in total 22.5 hours for group 1 and 45 hours for group 2.

**Article 5:** These courses will be held at the Diplomatic Academy, at the premises of the Ministry of Foreign Affairs, Luan Haradinaj Street, in Prishtina.

**Article 6:** The course will be held by a teacher, whose mother tongue is French.

**Article 7:** Pedagogical material will be provided by the Embassy of France in Kosovo.

**Article 8:** For 8 participants of the group A1.2, the Embassy of France finances annual subscription to the mediatheque of French Alliance in Prishtina.

**Article 9:** The Diplomatic Academy is committed to provide a classroom equipped with a CD player and white board.

**Article 10:** Enrolled participants engage, under the supervision of the Diplomatic Academy, to be present at least 8 hours of lessons during the whole session.

**Article 11:** In case of unmotivated absence of a participant in more than 6 hours of lessons, the Embassy of France reserves the right to cancel his registration.

**Article 12:** A certificate of completed courses will be issued to each participant at the end of the course session.

**Article 13:** The Embassy of France undertakes the registration fee for the exam DELF A1 for 8 participants of group A1.2.

**Article 14:** This protocol shall enter into force upon signature and will expire on June 1, 2015.

**Article 15:** This protocol is signed in four originals, two in French and two in Albanian Language.
