MEMORANDUM OF UNDERSTANDING

BETWEEN

THE DIPLOMATIC ACADEMY OF THE MINISTRY OF FOREIGN AFFAIRS OF THE
REPUBLIC OF KOSOVO

AND

THE MEDITERRANEAN ACADEMY OF DIPLOMATIC STUDIES

The Diplomatic Academy of the Republic of Kosovo and the Mediterranean Academy of Diplomatic Studies (hereinafter referred as “the Parties”),

RECOGNIZING the spirit of cooperation that exists between Malta and Kosovo and WILLING to promote closer collaboration in the training of diplomats;

Have agreed to the following:

Article 1

Purpose

The objective of this Memorandum of Understanding (MoU) is to promote regular contact and cooperation between the Parties.

Article 2

Cooperation

The parties will cooperate in the exchange of information and experiences concerning their respective programs of study and research, seminars and other academic and training activities.

The parties may explore the possibilities of other forms of cooperation within the scope of objectives of this memorandum.

Article 3

Issues of mutual concern

The parties will explore the possibility of exchanges of trainees, experts and researchers.

The parties will encourage cooperation in the fields of study and research, as well as in exchanging information on national and international publications, especially in areas of mutual interest.

Article 4

Exchange of information

The parties will exchange information and views related to international trends and advances in training and research in diplomacy, foreign policy, international relations, international law, foreign economic relations, political science and other relevant areas.

Article 5

Projects undertaken jointly

The parties will conclude protocols laying down the terms and conditions of any projects undertaken jointly.

Article 6

Financial conditions

The forms, duration and financial conditions of any projects, exchanges or any other activities undertaken in the context of this MOU shall be subject to prior agreement, in writing, between the Parties.

Article 7

Settlement of Disputes

Disagreements and disputes regarding the interpretation or application of this Memorandum will be settled between the Parties through consultations.

Provisions of this protocol may be amended by mutual written consent of the Parties.

Article 8

Entry into force


This Memorandum will come into effect on the date of its signature and will continue to have effect for a period of three years. Thereafter, it may automatically be renewed for equal periods, unless terminated by any of the Parties by giving a written notice of ninety (90) days to the other Party prior to the date of termination of the Memorandum. The termination of this Memorandum will not affect ongoing projects.
