MEMORANDUM OF UNDERSTANDING

BETWEEN

THE DIPLOMATIC ACADEMY OF THE MINISTRY OF FOREIGN AFFAIRS,
REPUBLIC OF KOSOVO

AND

THE "ÉCOLE NATIONALE D'ADMINISTRATION" (ENA),
REPUBLIC OF FRANCE

hereinafter referred as "the Parties",

RECOGNIZING the spirit of cooperation that exists between the Republic of Kosovo and the Republic of France;

RECOGNIZING the willingness to promote closer collaboration on training of diplomats between the Diplomatic Academy of Republic of Kosovo, located at the Ministry of Foreign Affairs Building, Prishtinë 10000 and the Ecole Nationale d'Administration (ENA) located at Sainte Marguerite Street nr. 1, F 67080 - Strasbourg - France;

Have agreed to the following:

Article 1
Purpose

The objective of this Memorandum of Understanding (MoU) is to create conditions for maintaining regular contacts and promoting cooperation between the Parties.

Article 2
Cooperation

The Parties will cooperate on exchange of information and experiences concerning their respective programs of study, seminars and other academic and training activities.

The Parties may explore the possibilities of other forms of cooperation under the scope of objectives of this Memorandum.

Article 3
Issues of mutual concern

The Parties will promote, contact and exchange trainees and experts in the field of diplomatic practice and especially the following:

- Organization of training sessions by ENA at the Diplomatic Academy of the Ministry of Foreign Affairs of Kosovo;
- Training of Kosovar diplomats by ENA in its Short International Specialized Sessions in Public Administration (CISAP);
- Training of Kosovar diplomats by ENA in its Long International Course (CIL) and International Advanced Training Course (CIP);

Article 4
Projects undertaken jointly

The Parties will decide the specifics and logistics of every project they jointly undertake.

For this purpose, protocols laying down the terms and conditions of the proposed exchanges will be concluded if necessary.

Article 5
Financial conditions

Forms, duration and financial conditions of exchange and training of representatives will be agreed between the Parties.

Article 6
Settlement of Disputes

Disagreements and disputes regarding the interpretation or application of this Memorandum will be settled between the Parties through consultations.

Provisions of this Memorandum may be amended by mutual written consent of the Parties.


Article 7
Entry into force

This Memorandum will come into effect on the date of its signature and will continue to have effect for a period of three (3) years. Thereafter, it may automatically be renewed for equal periods, unless terminated by any of the Parties by giving a written notice of ninety (90) days to the other Party prior to the date of termination of the Memorandum. The termination of this Memorandum will not affect ongoing projects.
