AGREEMENT OF UNDERSTANDING

between

THE DIPLOMATIC ACADEMY OF THE REPUBLIC OF KOSOVO

and

**THE FACULTY OF LAW OF THE UNIVERSITY OF PRISHTINA
“HASAN PRISHTINA”**

Diplomatic Academy of the Republic of Kosovo and the Faculty of Law of the University of Prishtina “Hasan Prishtina” hereinafter referred to as “Parties”;

Determined to sign this Agreement of Understanding with a view to cooperation and exchange of experiences in the field of diplomacy and international relations, international law and other academic disciplines;

Agree as follows:

Article 1 Purpose

Diplomatic Academy and the Faculty of Law of the University of Prishtina “Hasan Prishtina” will cooperate in the exchange of lecturers, providing lectures in the field of diplomacy, international law, modern political history, as well as study and research of topics of common interest.

Article 2

Cooperation

Both parties of the agreement have agreed to provide lectures, conferences and seminars for candidates on topics of common interest in the premises of the Faculty of Law of the University of Prishtina "Hasan Prishtina" and Diplomatic Academy of the Republic of Kosovo. Both institutions will cooperate mutually and shall provide each other proper assistance during the organization of events of common interest.

Article 3

Forms of cooperation

Diplomatic Academy of the Republic of Kosovo will provide lecturers from among the diplomats of the Republic of Kosovo, from among the diplomatic corps accredited to the Republic of Kosovo, as well as from international peer institutions. The Faculty of Law of the University of Prishtina "Hasan Prishtina" will provide lecturers as well.

Article 4

Publication of the works

Both institutions will facilitate the publication of works by both partners in the respective institutional bodies, as well as the texts of interest from other public or private institutions, whether local or international.

Article 5

Exchange of information

Diplomatic Academy of the Republic of Kosovo and Faculty of Law of the University of Prishtina "Hasan Prishtina" will exchange information of mutual interest, including joint or own participation in the meetings or international conferences.

Article 6

Financial aspects

This document constitutes the entire agreement between the parties. The agreement is not considered obligatory financial contract; it is designed for the effect of advancement, cooperation and institutional development of both parties.

Article 7
Entry into force, termination and amendment

This Agreement of Understanding enters into force on the day of signature and remains in force for five (5) years. The Agreement remains in force automatically for another five (5) years, if the parties do not begin the procedure of termination of this Agreement of Understanding.

This Agreement may be terminated by one of the signatories after a written notification, at least three (3) months prior to termination. The activities that have commenced before the written request for termination of the agreement will be completed according to the preliminary planning, except in cases where the parties agree to take another decision.

The provisions of this Agreement may be amended or supplemented by prior written consent of the Parties.
