The Ministry of Foreign Affairs of the Republic of Kosovo presents its compliments to the Ministry of Foreign Affairs of Montenegro and has the honour to inform that the Republic of Kosovo has completed internal legal procedures of ratification necessary for the entry into force of the Law No. 06/L-060 on Ratification on the Agreement on the State Border between the Republic of Kosovo and Montenegro consisting of three (3) integral parts as follows:

- The Agreement on the State Border between the Republic of Kosovo and Montenegro, signed in Vienna, on 26 August 2015;
- Joint statement of the President of the Republic of Kosovo H.E. Hashim Thaçi and the President of Montenegro H.E. Filip Vujanovic signed on 16.02.2018;
- Official records of the State Commission for demarcation of the State Border between the Republic of Kosovo and Montenegro as orientation;

The Ministry of Foreign Affairs of the Republic of Kosovo has the honour to inform that the Law No.06/L-060 on Ratification on the Agreement on the State Border between the Republic of Kosovo and Montenegro is published in the "Official Gazette of the Republic of Kosovo" no. 8/2018, dated 15 May 2018.

The Ministry of Foreign Affairs of the Republic of Kosovo, in compliance with the Law No. 06/L-060, specifically Article 12 of the Agreement on the State Border between the Republic of Kosovo and Montenegro, signed in Vienna, on 26 August 2015, which stipulates the procedure for its entry into force, informs that this note of the Republic of Kosovo constitutes the second of two diplomatic notes informing about the fulfilment of internal legal procedures necessary for the entry into force.
