AMENDMENT NO. 7 TO THE
ASSISTANCE AGREEMENT

Between

The United States of America, acting through the United States Agency for International Development ("USAID")

and

The Republic of Kosovo (hereinafter referred to as the "Grantee")

Purpose of Amendment

On September 14, 2009, the Parties entered into an Assistance Agreement for Economic Growth; on September 2, 2010, the Parties entered into an Amended and Restated Assistance Agreement; on September 1, 2011, the Parties entered into Amendment Number Two to the Assistant Agreement; on August 22, 2012, the Parties entered into Amendment Number Three to the Assistance Agreement; on September 17, 2012, the Parties entered into Amendment Number Four to the Assistance Agreement; on September 28, 2012 the Parties entered into Amendment Number Five, and on July 12, 2013 the Parties entered into Amendment Number Six to the Assistance Agreement (collectively, with this Amendment Number Seven, the "Agreement").

This Amendment Number Seven (the "Amendment") is hereby entered into between the Parties to provide the Grantee an additional increment of One Hundred Thousand U.S. Dollars (\$100,000) and modify the budget consistent therewith. This incremental addition of funds brings the total funds obligated to date under the Agreement to an amount not to exceed One Hundred and Forty-Five Million and Seven Hundred and Twenty-Two U.S. Dollars (\$145,000,722).

The Parties now wish to amend the Agreement as follows:

1. Article 3: Contributions of the Parties.

To increase the grant amount, Section 3.1(a) is hereby amended and replaced in its entirety by the following:

“(a) *The Grant.* To help achieve the Objective set forth in this Agreement, USAID, pursuant to the Foreign Assistance Act of 1961, as amended, hereby grants to the Grantee under the terms of this Agreement an amount not to exceed One Hundred and Forty-Five Million and Seven Hundred and Twenty-Two U.S. Dollars (\$145,000,722) (the "Grant").”

2. Annex 1 to the Amended and Restated Assistance Agreement Amplified Description

To modify the "Youth, Employment and Participation" Program Area and to provide an updated financial plan,

(a) Annex 1 is hereby amended by replacing the "Youth, Employment and Participation" Program Area with the following:

Youth Employment and Participation

USAID/Kosovo seeks to support young entrepreneurs to develop viable businesses and contribute to job creation. The goal is to address high youth unemployment.

Illustrative Activities:


- Entrepreneurial and enterprise training;
- Assistance to secure financial support;
- Technical assistance, mentoring, coaching and networking; and
- Peace Corps Volunteers will work directly with youth, as well as with local organizations and schools, to address economic development, youth, gender, minorities and inter-ethnic reconciliation issues.


(b) Annex 1 is further amended by replacing Attachment A to Annex 1 in its entirety by the Attachment to this Amendment.
